

11J LAUNDRY DESTAINING POWDER

Hazards for humans and the environment



Contains sodium percarbonate (Sodium Carbonate Peroxide), disodium metasilicate (Sodium Metasilicate)

Signal word:

Danger.

Hazard statements:

H314 - Causes severe skin burns and eye damage.

EUH071 - Corrosive to the respiratory tract.

Prevention and conduct



The following information applies for the uses indicated in subsection 1.2 of the Safety Data Sheet. If available, please refer to the product information sheet for application and handling instructions. Normal use conditions are assumed for this section.



Recommended safety measures for handling the undiluted product:

Covering activities such as filling and transfer of product to application equipment, flasks or buckets

Appropriate engineering controls:

If the product is diluted by using specific dosing systems with no risk of splashes or direct skin contact, the personal protection equipment as described in this section is not required.

Avoid direct contact and/or splashes where possible. Train personnel.



Appropriate organisational controls:

Personal protective equipment

Eye / face protection:

Safety glasses or goggles (EN 16321).

Hand protection:

Chemical-resistant protective gloves (EN 374). Consider specific local use conditions, such as risk of splashes, cuts, contact time and temperature.

Body protection:

Wear chemical-resistant clothing and boots in case direct dermal exposure and/or splashes may occur (EN ISO 13982-1).

Respiratory protection:

If exposure to dust cannot be avoided use: half mask (EN 140) with particle filter P2 (EN 143) or full-face mask (EN 136) with particle filter P1 (EN 143). Consider specific local use conditions. In consultation with the supplier of respiratory protection equipment a different type providing similar protection may be chosen.

Environmental exposure controls:

Should not reach sewage water or drainage ditch undiluted or unneutralised.

Recommended safety measures for handling the diluted product:

Appropriate engineering controls:

No special requirements under normal use conditions.

Appropriate organisational controls:

No special requirements under normal use conditions.

Emergency procedure



Suitable extinguishing media

Carbon dioxide. Dry powder. Water spray jet. Fight larger fires with water spray jet or alcohol-resistant foam.

Environmental precautions

Do not allow to enter drainage system, surface or ground water.

Methods for cleaning up

Ensure adequate ventilation. Collect mechanically. Do not place spilled materials back into the original container. Collect in closed and suitable containers for disposal.

First aid measures



Inhalation:

Remove person to fresh air and keep comfortable for breathing. Immediately call a POISON CENTRE, doctor or physician.

Skin contact:

Wash skin with plenty of lukewarm, gently flowing water for at least 30 minutes. Take off immediately all contaminated clothing and wash it before reuse. Immediately call a POISON CENTRE, doctor or physician.



Eye contact:

Hold eyelids apart and flush eyes with plenty of lukewarm water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTRE, doctor or physician.

Ingestion:

Rinse mouth. Immediately drink 1 glass of water. Never give anything by mouth to an unconscious person. Do NOT induce vomiting. Keep at rest. Immediately call a POISON CENTRE, doctor or physician.
